Subject:- Grant of N.O.C. of the Punjab Government to start new institute for B.Ed. Course from the session 2005-06 at Village Handiaya Road, Barnala, in the name of Sacred Heart International College of Education.

Reference your application on the subject noted above.
2. The N.O.C. of the Government of Punjab is granted to start new institute for the course B.Ed (100 seats) in favour of Sacred Heart Educational & Welfare Society, Barnala, Session 2005-06 subject to the following conditions namely:-

- i) That the applicant Trust is registered Trust and has land measuring 10 acres in the name of Trust exclusively for this college and building as per norms of N.C.T.E. Land use as Educational will be obtained from the Competent Authority.
- ii) That the applicant Trust will construct the requisite building on the land already earmarked for the purpose and submit the completion certificate from the competent authority as per norms and standards.
- iii) That the applicant Trust will also obtain clearance from the affiliating University.
- iv) That the applicant Trust can run the B.Ed. College temporarily in the building at Handiaya Road, Barnala, as shown in the application till building is constructed at Handiaya Road, Barnala. As per N.C.T.E. instructions time for use of alternate building will not be exceeding three years.
- v) That the management of the Trust will ensure that the conditions of basic requirements/norms and standards of the Punjab Government Punjab University, Patiala /N.C.T.E. are fully complied with.
- vi) That no financial assistance/ grant will be given by the Government to the institute.
- vii) That in case, if any stage, any limit for fees is prescribed by the Government, the Institute will comply the same.
- viii) That this approval is provisional and the same can be withdrawn at any time.
- ix) For the subject combinations, the institute will offer the subjects as per directions if any, of the affiliating University.
